- (i) promoting societal engagement through debates, campaigns, awarenessrising, conferences, workshops etc. on the themes relevant to call priorities and providing a link to the European political agenda and policy making process;
- (ii) gathering the opinions of individuals through a bottom-up approach (including use of social networks, webinars etc.) and media literacy;

#### **Priority 1 - e-Justice**

Priority given to the development of concrete cases on the use of artificial intelligence and distributed ledger technology in the justice area
